NAVARRE BEACH YACHT CLUB CHARTER

Article I

The official name shall be The Navarre Beach Yacht Club (hereafter referred to as 'the club').

Article II

The sole purpose of the club is to provide a venue for the fun and enjoyment of the members (hereafter referred to as 'Captains'). The club is to provide a milieu whereby Captains can share their boating enthusiasm with people of like attitudes. Any outing extra curricular to boating shall be considered foreign to this Charter.

Article III

Since the accrual of a bank account is not within the purposes of the club, dues will be kept to an absolute minimum. At the end of each tenure of office a strict accounting shall be required of the Purser and any excess funds will be returned to the Captains in a form so chosen by the Officers. (I.E., a membership party, reduction of dues, etc.)

Article IV

At any and all club outings, the individual Captain assumes sole responsibility for the conduct of their boat/crew, and in no way can the club be held accountable for the conduct of any Captain, or any Captain's boat/crew.

NAVARRE BEACH YACHT CLUB BY-LAWS

1. Membership meetings will be on the first Monday of each month.
2. Dues are paid from Feb 1 to Feb 1 each year. (Amended Nov 03 election.)
3. There will be seven officers: Commodore, Vice Commodore, Recorder, Purser, Sailor at Large, Power Boater at Large, and Last Year's Commodore.
4. All officers will be elected. Elections will be held in December and installation of officers will be in January.
5.
 - a. Management issues will be decided by the officers.
 - b. Activities issues will be decided by the members.
 - c. Management issues may be submitted by the members to the officers.
6. No activities can be authorized that are counter to Juana's lease, laws or operations.
7.
 - a. The club charter may be changed only after proper notice to all members is given by mail and three fourths of all votes returned are affirmative.
 - b. The club by-laws may be changed in the same manner with two thirds of returned votes affirmative.
 - c. Additional by-laws may be added by unanimous vote of the officers.
8. Charter members may fly a pink or blue streamer just above the yacht club burgee.
9. The board of officers, by majority vote, may approve expenditures up to \$100. Expenditures over \$100 must be approved by a simple majority of general membership present at a regularly scheduled membership meeting. Committees should present their budgets to the board prior to the general membership meeting. The board will present the proposed budget to the membership for vote.
